

## **Lovett Farms 2008 Liner Program**

**Effective Dates:** January 1, 2008 (week 1) – December 30, 2008 (week 52)

**Pricing:** This is the broker's net price and is subject to change with notice. Special quotes maybe given on extremely high volume customers.

**Liner Sizes:** Our liners are produced in 60 and 24 cells. Occasionally we will have other tray sizes and a price will be quoted for those items as available.

**Placing Orders:** The broker must fax a purchase order to our office at (863)773-2665 before an order can be acknowledged and shipped. Most orders that are placed 12- 20 weeks before shipping can be produced to order. Late orders are subject to availability.

**Minimum Orders:** 1 Box, 3 trays for 60 & 40 cell. 1 Box, 2 trays for 21 & 24 cell  
Please order in even packing.

**Freight:** We ship via Grower Truck deliveries in most of Florida, freight companies, FedEx Freight, and customer pick up. Grower truck deliveries are available for orders that meet a \$500.00 minimum; those orders that do not meet minimum will have a \$75.00 drop charge. Also Fuel Surcharge of \$35.00 will be charged on every delivered order. The same charges apply for orders that do not meet minimum and are going to Tampa International Airport. All other arranged shipping will be billed on broker's accounts. If the broker is unable to provide account #, then the freight will be pre-paid and added to the invoice. **Lovett Farms will no longer assume any responsibility for shipments damaged by ground shipping. This includes Fed Ex Ground, UPS, DHL etc.**

**Box Charges:** A box charge of \$4.00 will be added for all boxing requests. Our box holds (3 or 2) trays and is 12"x 21"x 25".

**Phytosanitary Certificate:** Any phytosanitary certificates needed, will be added to the invoice at \$70.00.

**Order Cancellations:** Custom orders cancelled within 8 weeks from delivery date will be billed to the broker. The broker may however resell the product to another ship to customer.

**Shipping Damages:** Any damaged boxes must be reported in writing via fax to the shipper and our office immediately upon receipt of product. A claim by the customer must be made with the carrier's driver at the time of delivery. If Lovett Farms receives a credit from the carrier, it will be passed on to the broker/customer. Lovett Farms will no longer assume any responsibility for shipments damaged by ground shipping. This includes Fed Ex Ground, UPS, DHL etc.

**Credits:** *In order to receive credit on any material our office must be notified within 48 hours of receipt of order. Our office must issue a return authorization number to be used to reference the credit requested. You must contact your sales representative for this authorization number. Credit will only be issued following approval, after we review the conditions regarding your request.*
